PRICE LIST FORMAT

Page Numbering - Sheet numbers appear in the upper right corner of the page. Sheets are numbered sequentially. However, new sheets are occasionally added to the price list. When a new sheet is added between sheets already in effect, a decimal is added. For example, a new sheet added between sheets 1 and 2 would be sheet 1.1.

SYMBOLS

Explanation of Symbols - When changes are made in any price list sheet, a revised sheet will be issued canceling the price list sheet affected. Changes will be identified on the revised sheet(s) through the use of the following symbols:

- (C)** - To signify changed condition or regulation.
- (D)** - To signify discontinued rate, regulation or condition.
- (I)** - To signify an increase.
- (L)** - To signify material relocated from or another part of this price list with no change in text, rate, rule or condition.
- (N)** - To signify new material, including a listing, rate, rule or condition.
- (R)** - To signify a reduction.
- (T)** - To signify a change in the wording of text, but no change in the rate, rule or condition.

SECTION 1 – SERVICE DESCRIPTION AND RATES

1.1 General

1.1.1 The Company offers outbound direct dial (1+) and inbound toll-free (e.g., 800 or 888) number long distance services to its Customers. The Company's long distance service charges may vary based upon call duration, call type, and or calling plan. All Company services are available 24 hours a day, seven days a week.

1.1.2 Access to the Company's Services is provided via Switched Access from locations served by equal access end offices.

1.2 Timing of Calls

Billing for calls placed over the Company's network is based in part on the duration of the call as follows, unless otherwise specified in this Pricing Guide:

1.2.1 Call timing begins when the called party answers the call (i.e., when two way communications are established.) Answer detection is based on standard industry answer detection methods, including hardware and software answer detection.

1.2.2 Chargeable time for calls ends when one of the parties disconnects from the call.

1.2.3 For billing purposes, minimum call duration periods vary by service and are specified by product or option in subsequent sections of this Pricing Guide.

1.2.4 For billing purposes, usage after the initial period varies by service and is specified by product or option in subsequent sections of this Pricing Guide.

1.2.5 The Company will not bill for unanswered calls. When a Customer indicates that he/she was billed for an incomplete call, the Company will reasonably issue credit for the call.

1.3 Rate Periods

Rates for service are not time-of-day or distance sensitive.

1.4 Direct Intrastate Service

Direct Intrastate Service is available to business and residential Customers for outbound and inbound calling. This service is available to both presubscribed Customers and casual callers. Calls are billed in six (6) second increments after an initial minimum period of thirty (30) seconds, and originate and terminate on Customer-provided switched access lines. Rates are not mileage or time-of-day sensitive. This service is offered on a month to month basis. No minimum commitment is required.

Intrastate service is offered in conjunction with interstate and international service.
